4. Details of our assessment

A routine effluent sample collected from Bro Nant Sewage Treatment Works (STW) on the 03/08/26 was found to contain 84mg/l Suspended Solids against a permit limit of 30mg/l.

There was also a result for BOD: 5 Day ATU of 37 mg/l against a permit limit of 20 mg/l.

These results are a permit breach and are scored accordingly.

Please respond to NRW with the reasoning behind these failures by 14/09/26.
