4. Details of our assessment

This Compliance Assessment Report (CAR) follows an unannounced site visit to 2 sisters conducted by NRW officers on 6th August 2026.

Prior to attending site NRW officers completed an odour monitoring assessment around the boundary of the site, detecting a faint lairage and offal odour on Hamilton Avenue, and at the top of Glendale Avenue. Upon attending site, it was identified that the probable odour source was the loading of a CAT3 trailer. Loading of the waste had concluded by the time of inspection, the trailer doors were closed and other odour management measures were being followed. After leaving site NRW officers returned to Hamilton Avenue and could not detect any further odour.

Odour on site

NRW officers were accompanied around site by H&S Manager, Engineering Manager, & Operations Manager. The main drainage areas of the site were attended and inspected, this included the drains in the rear yard, ETP drainage channel, and the 6m balancing tank. The effluent discharge exit pit was inspected and no issues were identified.

The gantry and rear yard area were observed to be clean and tidy. The roller shutter doors for the PRP room were closed and all other measures in the odour management plan were being adhered to.

At the back of the yard, towards the steps over the chiller building, blood was identified on the ground leaking from an IBC, and feathers were seen gathering in the drainage gulley. There was only a very slight odour detected from the IBCs due to the waste being sprayed with a deodoriser. However, the Yard and Roadway Cleaning Procedure (YAR001- 11/12/2025) was not being followed, this states: "Check that the grids covering drains are free from debris and gullies are flowing freely".

A category 3 score has been applied against permit condition 1.1.1 under subheading IR1A.

Action: Ensure the gully in the rear of the EV yard is cleared all all debris and feathers.

Action: Ensure all aspects of cleaning procedures are being followed.

NRW officers were accompanied round the rest of the site including visiting the despatch bay noting

no issues. The Operator also confirmed Bay 1 was not used at night.

Roof Works

Work on replacing the roof of the Despatch building, at the rear of the site, in June had been halted as a result of birds nesting. The site were advised to wait until it was confirmed that all birds had fledged before recommencing the works again. Ecolab have confirmed the last bird has fledged and that it is safe to proceed with the roofing works. It is advised that the Operator keeps the Local Community Council informed of these works, along with NRW.
