4. Details of our assessment

A routine site inspection took place on Wednesday 12th August 2026.

NRW Officers were accompanied by a representative from North Wales Minerals Planning service.

The aim of the inspection was to check on the progress of waste tipping and placement in line with the site's filling plan.

Upon arriving at site, plant machinery was being used to spread waste on the highest part of the landfill. There looked to be some recent waste deposits just slightly down hill, on the eastern side of the site.

Edward Griffiths (permit operator/TCM) accompanied staff to the tipping face of the landfill. Here, it was queried how waste was being tipped in line with the site's filling plan and also queries made regarding monitoring and long term management of the landfill.

Edward was unable to answer permit related queries and officers were told to direct these queries to a relative of the operator. Given that Edward is the TCM and the site was open to accept and deposit waste on site, it was concerning to officers that the TCM/permit operator did not have knowledge of the filling plan and other compliance issues on site.

This has raised wider concerns about the competence of the permit operators and TCM. Ultimately the operator is responsible for managing waste activities on site and ensuring compliance with the environmental permit. As well as ensuring compliance with the permit, the TCM should have good regulatory oversight and understanding of the waste activities and environmental aspects of the landfill. A lack of knowledge regarding the filling plan, landfill gas generation and surface water sampling results, suggests the operator may lack competence.

A further inspection will be arranged to meet with the appropriate person overseeing site operations and competence will be discussed further.
