4. Details of our assessment

This was a prearranged site inspection of the facility by the Natural Resources Wales (NRW) regulating officers.

An initial meeting was undertaken with the Environment Manager, Operations Manager and Plant Manager to discuss the current status of the facility with respect to the requirements of the permit and discuss any proposed plans and changes. The progress of the pilot plant was also discussed. The salient points are summarised below.

Carbon Capture Pilot Plant Trial

The Carbon Capture Pilot Plant trial is completed and the unit has been disconnected and is pending imminent removal from the site.

Park and Sanitary Waste Temporary Storage

A proposal to utilise a former on-site ash storage bunker for the immediate offloading and temporary storage of park and sanitary waste was submitted to the NRW by the Operator (Action 1 CAR Reference NRW0048381). NRW agreed the minor operational changes, as per CAR reference CAR_NRW0049661. The Operator has confirmed that, to date, the use of the former ash barn for temporary storage of park and sanitary waste has not yet been required.

Following the meeting, a brief high-level tour of the external areas of the facility was undertaken. The site was well managed, ordered and tidy at the time of the visit; no non-compliances were identified.
