4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q1 (January - March) and Q2 (April - June) 2026 monitoring returns by Dunbia (UK) for activities at Cross Hands Meat Processing Plant, Cross Hands Business Park West, Llanelli SA14 6RF under permit EPR-BU8002IT.

Q1 and Q2 2026 Monitoring Returns

Emissions to water - Water 1 / 13/04/2026 and 13/08/2026

The returns for reporting of sampling and analysis of emissions to water (other than sewer) to discharge point **W5** for:

- **Q1** (1 January - 31 March 2026), and
- **Q2** (1 April - 30 June 2026)

were submitted to NRW on 21 April and 14 August 2026, respectively.

Emissions to sewer - Sewer 1 / 13/04/2026 and 13/08/2026

The returns for reporting of sampling and analysis of emissions to sewer to discharge point **S1** for Q1 and Q2 2026 were submitted to NRW on 21 April and 14 August 2026, respectively.

Compliance Summary

- The monitoring data for **Q1** 2026 was submitted within the required reporting period, in compliance with permit condition 4.2.3.
- The monitoring was carried out during the correct **Q1** and **Q2** monitoring periods, meeting the requirements of permit condition 3.5.1.
- Based on the information provided in the monitoring reports, all other emissions at the specified monitoring points appear to be compliant with the permitted limits for the **Q1** and **Q2** 2026 reporting periods.

Compliance Breach

The monitoring data for Quarter 2 was submitted to NRW on 14 August 2026. However, permit condition 4.2.3 requires Q2 monitoring data to be submitted within the specified grace period, ending on **31 July**. Accordingly, the Q2 monitoring return was submitted 14 days after the permit

deadline.

In accordance with NRW's compliance scoring guidance, a non-compliance score of **C4** has been recorded against sub-criteria IR4B.
