Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

This was an unannounced site visit made by Alex Underhill of Natural Resources Wales (NRW). The purpose of the inspection was to assess compliance against the Standard Rules SR2012 No15 Environmental Permit EPR-AB3598HR.

The weather was clear with recent hot weather being noted.

Previous inspection:

Two category 3 (minor) permit breaches were observed during the last inspection dated 01/11/2023. The first was to ensure that all wastes are stored in line with **condition 2.3.1** and **table 2.3**, namely storing waste oils on an impermeable floor.

The second breach was for **conditions 1.1.1 (b)** and **1.1.4** of the permit, the site is required to use sufficient competent persons and resources and comply with the requirements of an approved competence scheme. Please see Compliance Assessment Report (CAR) CAR_NRW0042736 for further detail.

Permit Breaches:

No permit breaches were observed during this inspection.

General observations:

The site was generally clean and well organised with good segregation of waste types and good waste storage practices were observed.

General Management (W1A):

The site is required to be operated in accordance with a written management system that identifies and minimises risks of pollution.

The Site (W2D):

All specified waste sections were kept separate and site was well maintained, with good housekeeping across the site. Waste transformers and oils were all stored on the impermeable flooring inside the drainage bunds. This satisfies the action from the previous CAR form for **condition 2.3.1** and **table 2.3**. Drainage bunds filter down to the interceptor at the bottom of the site. The interceptors are routinely checked and emptied, with drains on site being clear apart from one with a small build-up of dust.

ACTION – Ensure that the drain covers leading to the interceptors are routinely kept clear. The bottom drain under the creosoted posts was covered in places by a build-up of dust and leaves.

Reporting (W4B):

Up to date Site Permit were readily accessible on site. Latest Waste Return Notes up to date, up to Q2 2026.

Technical competence:

The Technically Competent Manager (TCM) for the site now holds the appropriate TCM certification through “EU Skills” scheme, which is recorded on NRW systems. This satisfies the action from the previous CAR form for **conditions 1.1.1 (b)** and **1.1.4** of the permit. The TCM was not available during the time of inspection, so the certificate for continued competence will be reviewed during the next inspection.
