4. Details of our assessment

Thank you for submitting your Climate Change Risk Assessment (CCRA) for Biffa Trecatti. We have completed a light-touch review of the assessment against NRW's CCRA requirements. Please note: the review is considered a light touch review, only to assess if the CCRA is up to date and includes the expected information, it is not a technical review.

CCRA Review

A suitable management system can minimise the environmental risk from permitted activities. The submitted Climate Change Risk Assessment includes site-specific information, relevant climate hazards, future climate scenarios and a detailed risk assessment with mitigation measures. However, the assessment does not fully meet NRW climate change risk assessment requirements as it does not clearly assess short, medium and long-term climate risks, does not clearly prioritise exposed elements at risk, does not contain key performance indicators to measure adaptation performance and does not include a documented process for periodic review and continuous improvement.

Please ensure the revised assessment:

- Clearly assesses climate risks over short, medium and long-term timescales.
- Identifies and prioritises all elements exposed to climate risk, including assets, infrastructure, operations, supply chains, people and environmental receptors.
- Includes measurable key performance indicators to monitor adaptation and resilience performance.
- Includes a documented review procedure detailing how and when the assessment will be updated in response to new climate information, operational changes or significant weather events.
- Continues to identify and implement actions to manage the most significant climate-related risks.

A robust management system helps ensure environmental risks associated with permitted activities remain effectively controlled as climate conditions change. While the assessment provides a good foundation, the points above need to be addressed to demonstrate a comprehensive approach to climate change adaptation and continual improvement.

ACTION: Provide a revised CCRA to include the recommendations highlighted within the CAR Form and submit to Natural Resources Wales by **18/10/2026**.

Following this, the next step is for you to develop a Climate Change Adaptation Plan (CCAP) based on the findings within your CCRA and integrate into your management system. The detail in your CCAP should reflect the risk that climate change creates for your operation.

Following the Regulation 61 Notice issued to Biffa Trecatti, this CCAP will need to be completed and submitted to NRW by **01/04/27**.
