4. Details of our assessment

Thank you for submitting your Climate Change Risk Assessment (CCRA) for Cenin. We have completed a light-touch review of the assessment against NRW's CCRA requirements. Please note: the review is considered a light touch review, only to assess if the CCRA is up to date and includes the expected information, it is not a technical review.

CCRA Review

A suitable management system can minimise the environmental risk from permitted activities. Following a light touch review of the submitted Climate Change Risk Assessment, several elements required by NRW's Climate Change Risk Assessment checklist have not been adequately addressed.

We have carried out a basic review of the assessment and identified areas requiring improvement before it can meet NRW's current climate change risk assessment requirements.

The revised assessment should:

- Reference recognised current and future climate projections and scenarios relevant to the site.
- Assess climate risks across short, medium and long-term timescales.
- Identify and prioritise elements exposed to climate risk, including assets, infrastructure, operations, supply chains, environmental receptors/ecosystems and people.
- Include a risk prioritisation methodology identifying high-priority climate risks.
- Include key performance indicators (KPIs) to monitor adaptation measures and environmental performance.
- Include arrangements for regular review and updating of the assessment following climate-related incidents, near misses, changes to operations or updated climate projections.
- Further demonstrate how climate risks are specific to the permitted site, including local flooding, drainage, infrastructure and operational vulnerabilities.

The assessment identifies a range of relevant climate hazards and contains several appropriate mitigation measures; however, the additional information listed above is required to demonstrate that climate change risks are being systematically assessed and managed through the site's environmental management system.

Please update your Climate Change Risk Assessment and submit a revised version to

Natural Resources Wales by **18/10/2026**.

Following this, the next step is for you to develop a Climate Change Adaptation Plan (CCAP) based on the findings within your CCRA and integrate into your management system. The detail in your CCAP should reflect the risk that climate change creates for your operation. Following the Regulation 61 Notice issued to Cenin, this CCAP will need to be completed and submitted to NRW by **01/04/27**.
