#### **4. Details of our assessment**

On the 11th August 2026 NRW samplers took a compliance sample at BERTHLWYD HALL HOLIDAY PARK Permit CG0093101.

The samples have been analysed and verified and the following results have been given

Suspended Solids (SS) - **92mg/l** the permit limit for this site is **27mg/l**.

The operator (R S & L H DAVIES) is required to carry out the following actions -

- The operator must carry out a full investigation to determine why the permitted treatment plant is not meeting its required limits for Suspended Solids. This should include reviewing plant performance, operational practices, and key treatment processes to identify any issues and implement corrective actions **Due date 30th September 2026**
