4. Details of our assessment

Compliance inspection of Llancarfan STW AG0009201 undertaken by Environment Officer Harry Warburton, accompanied by DCWW. Weather at the time was drought conditions.

The site consists of an on-site pumping station, inlet, primary settlement tank, percolating

filter bed, humus tank, sludge drying beds, sampling point and outfall.

The permit has been varied as of June 2026. This is to include an iron emissions limit due to the site soon to include ferric dosing for phosphate removal at the inlet.

Inlet

The inlet for this site consists of a pumping station that pumps the flows up to the primary settlement tank with a copa sac on the outlet of the settlement tank.



Secondary treatment

Following the settlement tank the effluent enters a percolating filter bed which then flows to a humus tank. Both of these were in good order.

**Sludge drying bed, sampling point and outfall**

There are 2 of the 4 sludge drying beds in use, the sludge from here is tankered away and the remaining effluent returns to the inlet pumping station for recirculation. The outfall was inspected and there were no signs of impact to the watercourse.
