4. Details of our assessment

A final surrender inspection was undertaken on 28 August 2026 by Matthew Davies and Michael Edwards of Natural Resources Wales (NRW) to assess whether the regulated facility had been returned to a satisfactory state, having regard to the condition of the site prior to the commencement of permitted activities.

At the time of the inspection, the site remained non-operational and no waste activities associated with the environmental permit were being undertaken. No waste was present within the permitted area and there was no evidence of waste operations being carried out.

The site was observed to be secure and in a satisfactory condition. The land is currently under the control of Swansea Council and is being used for the temporary storage of new wheeled bins ahead of a future rollout to Swansea residents. The wheeled bins observed on site were clean, empty and unused, and were not being used for the storage, transfer or handling of waste. Their presence on site is unrelated to the former permitted waste operation and does not constitute a waste management activity.

No evidence was identified of any ongoing pollution risk associated with the previously permitted activity. The permitted area appeared to have been cleared and there were no visible accumulations of waste or waste-derived materials present during the inspection. The site was found to be secure and maintained in a condition that would not give rise to pollution or harm to human health.

Based on observations made during the inspection, NRW is satisfied that the regulated facility has been returned to a satisfactory state, having regard to the condition of the site before operations commenced. The surrender criteria have therefore been met.
