We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

On the 6 August 2026 a routine sample was collected by Natural Resources Wales from the sample point of the Sewage treatment plant serving 13 Dwellings on Land Adjacent Pentre House Leighton and revealed an exceedance in the following discharge parameters.

Non-Compliances (recorded in summary) Actions to be addressed –

Suspended solids (measured after drying at 105° C)

Permit limit 45mg/l

Sample result 108mg/l

This result represents a significant breach and has been assessed as a Category 2 environmental impact (significant). We are currently considering our enforcement action.

Please ensure the sewage treatment plant serving 13 Dwellings on Land Adjacent Pentre House Leighton brought back into regulatory compliance and provide any evidence of works carried out to action this to NRW by the 21 September 2026.
