4. Details of our assessment

Natural Resources Wales Officer Shaun Rees met with Mr Davies to carry out an inspection in regards to the sites EPR sheep dip permit on the 10 August 2026 at 13:45.

Mr Davies stated during the inspection, that the farms sheep are dipped by a sheep dip contractor and any used sheep dip is taken away by said contractor after dipping, even though no disposal to land takes places, an Environmental Management System is still required by the permit and has resulted in an non compliance.

Mr Davies also stated during the inspection, that the farm are thinking of dipping sheep again themselves in a purpose built system.

Documents to assist you in ensuring that an EMS in put in place have been provided in a hard copy format sent with this report, along with sheep dip guidance and guidance on records to be kept if the site decide to commence with the dipping of sheep themselves.
