4. Details of our assessment

Thank you for submitting your Climate Change Risk Assessment (CCRA) for Infinis Bryn Pica. We have completed a light-touch review of the assessment against NRW's CCRA requirements. Please note: the review is considered a light touch review, only to assess if the CCRA is up to date and includes the expected information, it is not a technical review.

CCRA REVIEW

The CCRA contains relevant climate hazards and considers short, medium and long-term risks. The document also contains strategic information and generation mix projections. However, there are some areas where further information is needed before the assessment can fully meet NRW's requirements.

In particular, the assessment should:

- Ensure the assessment is specific to the permitted installation rather than the wider Infinis portfolio.
- Use current climate projections and clearly reference the data and scenarios used to assess future climate impacts.
- Identify and prioritise all elements exposed to climate risk, including assets, infrastructure, operations, supply chains, ecosystems and people at the site.
- Include a prioritised adaptation action plan for significant risks, including timescales and responsibilities.
- Include key performance indicators (KPIs) to monitor climate resilience and adaptation performance.
- Include a documented review and update process linked to new climate data, significant incidents, near misses and emerging climate trends.
- Demonstrate how climate-related risks have been incorporated into the site's environmental management system.

A robust management system helps ensure environmental risks associated with permitted activities remain effectively controlled as climate conditions change. While the assessment provides a good foundation, the points above need to be addressed to demonstrate a comprehensive approach to climate change adaptation and continual improvement.

ACTION: Provide a revised CCRA to include the recommendations highlighted within the CAR Form and submit to Natural Resources Wales by **09/10/2026**.

Following this, the next step is for you to develop a Climate Change Adaptation Plan (CCAP) based on the findings within your CCRA and integrate into your management system. The detail in your CCAP should reflect the risk that climate change creates for your operation.

Following the Regulation 61 Notice issued to Inffinis Bryn Pica, this CCAP will need to be completed and submitted to NRW by **01/04/27**.
