4. Details of our assessment

This Compliance Assessment report follows an announced visit and inspection of the site on 06/07/2026.

The regulatory officer was accompanied by NRWs Air Quality and Noise Team (AQNT). The AQNT conduct technical assessments of operators' submissions to NRW to support regulatory and permitting assessments.

Officers met with the Operations Director, Chief Financial Officer and Environmental Manager.

Site visit

Officers viewed the site from an elevated position (K7 stack). The AQNT were able to see the emission points, understand the site layout and size and view the location within the surrounding environs; this should assist with visualising the site when reviewing future documents.

The monitoring of dioxins and furans was being undertaken from A26 (K7 biomass boiler) and A29 (MDF2 cyclones) concurrently at the time of the visit. The monitoring personnel did not indicate that there were any issues during the monitoring, however, they had noted a slight change when MDF2 went down temporarily.

The Operator confirmed works to the K7 chimney flap were planned for the end of July. There was still a vibration from the resi-gas fan but the Operator stated that this had been rebalanced and would be reviewed again.

The fuel on the K7 grate was free from contamination. Small amounts of water were being added to the fuel as it was too dry.

The temperatures of both boilers K7 and K8 were reviewed and operating as expected. No issues were identified in relation to the operation of either boiler.

The Operator confirmed that vents are opened in the particleboard building during periods of heat to ventilate the area.

Odour assessment

Officers were in Chirk between 10:45 and 17:00 to undertake odour assessments.

Prior to the inspection, an odour assessment was undertaken during the morning in response to a number of odour reports from the weekend and that morning. A slight wood odour was detected on Holyhead Road near to Lodgevale and the Co-op.

Immediately prior to the site visit a compost/wood odour was detected near to the the Co-

op, and an MDF odour was noted at the site entrance. A chocolate odour from Mondelez was also detected in the car park.

Following the visit, a further odour assessment was undertaken as NRW's Incident Communications Centre had received additional reports of odour in the Maes Y Waun / Maes Yr Ysgol area during the afternoon whilst officers were on site. A very faint MDF odour was noted at the top end of Maes Y Waun, near to The Nurseries. Officers subsequently walked the area and during a conversation with local residents a transient and intermittent MDF odour along with a chocolate odour was detected.

Officers stated that they had been on site prior to the inspection and had not identified any issues in respect of the operations during the visit.
