Weather and Catchment Conditions

Weather conditions on the day of the inspection were overcast. The visit was undertaken following a period of heavy rainfall within the catchment. However, it was noted that the catchment had experienced exceptionally dry conditions during the preceding months.

Site Description and Operation

HENRHYD STW serves a population equivalent of up to 119 people from nearby residential properties. The treatment works consists of a single Rotating Biological Contactor (RBC).

During the inspection, officers observed both the inlet to the RBC and the final chamber. No operational issues or defects were identified, and the asset appeared to be functioning as intended at the time of the visit.

It was also noted that ammonia and turbidity monitoring equipment had been installed on site. Both monitors were active and recording data during the inspection.

Outfall Inspection

It was not possible to inspect the outfall due to significant vegetation growth preventing safe access to the discharge point.
