Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

A routine effluent sample collected from Waters Edge Leisure Park on 04 June 2026 was found to contain 19.1mg/l ammoniacal nitrogen. As per permit condition 1.6 on your permit, the discharge shall contain no more than 10 mg/l.

Due to the volume discharged being so small in relation to the size of the Teifi Estuary, the dilution factor is believed to be significant. As a result, the exceedance has been recorded as a category 3 non-compliance; a non-compliance which could have a minor environmental effect.
