4. Details of our assessment

This was a pre planned site inspection carried out by Natural Resources Wales (NRW) officer Ffion Quan who was accompanied by the caravan park manager.

NRW officer Ffion Quan arrived on site at 10:30.

The process

One of the systems at Greenfields Caravan Park comprises of a septic tank discharging to ground at NGR SN35376 52311. The septic tank has a permitted maximum daily discharge of 7.5 m³/day, and the system only receives foul wastewater from the toilet and shower block facilities in the swimming pool area. It is important to ensure that the volume of effluent discharged to the system does not exceed the permitted maximum flow rate.

All other foul waste from the caravan park is directed towards a separate system on site.

The septic tank is routinely inspected by site staff, and a local waste management company undertakes the maintenance and desludging of the system as required.
