4. Details of our assessment

This report details the site visit made on the 18 August 2026 to Summerleaze Pet Crematorium, Green Street Farm, Green Street Lane, Redwick, Magor, NP26 3DY, Permit number EPR-CP3595SX.

NRW Officers Carla CURTIS, Anna ANDREWS and Taj PADAM attended site at 12:30 to conduct an unannounced routine inspection, Mr. Paul SCOTT (Operations Manager & TCM) accompanied officers around the site. Weather conditions were warm and overcast at the time of inspection.

GENERAL OBSERVATIONS – This site operates as an incinerator and Waste Transfer station, the incinerators were operational at the time of the visit and general housekeeping on site was good. Yellow bins were clearly separated and labelled, and the impermeable surface of the yard showed no issues with drainage. No waste(s) of any type were stored outside of the permit boundary and there were no offensive waste odours or excessive noises noted by NRW Officers during the site inspection.

TECHNICAL COMPETENCY - The site TCM (Technically Competent Manager) is Mr. Paul SCOTT whose certificate was observed in the office and expires 21 October 2027.

WASTE RETURN SUBMISSIONS - These appear to be up to date and correct. The total quantity of waste accepted at this site must not exceed 1,400 tonnes per year. Based on the submitted waste return data for the last four quarters of 2025/2026, the total waste accepted was 330.97 tonnes which is within the site's annual threshold.
