On 20th August a routine inspection was carried out to assess compliance with permit conditions.

On arrival the distribution arms were rotating freely.

Site not discharging, no litter, odour or fungus at the discharge point.

Note: Iron dosing unit being installed. Workmen on site, not disturbing treatment process. Phosphate limit comes into force on 28/01/2028.

I am pleased to report, on the day of my inspection the site was **compliant** with permit conditions.

Action

Sheep were in the compound which could cause an impact on the treatment process (damage to works) along with Health & Safety issues.

Please ensure the hole in the fence is fixed as soon as possible.
