On 30th September, 2019 a compliance sample was taken at Morfa Bychan Caravan Park from the package treatment plant (Permit reference BN0064401). The sample returned a result of 33mg/l Suspended Solids, which is in breach of the permitted limits of 30mg/l. As this is within 10% of the permit limit, it has been given a CCS score of 4 due to the low likelihood of any environmental damage as a result of the failure.
