There were areas of the site that had been completed with an estimated 50K tonnes of waste to be brought on to finish the project.

Waste piles (pre and post treatment) were checked and waste types conformed to those specified in the permit, there were some minor contaminants observed in the waste piles but these were of such a small amount that they were well within the limits for contamination.

There was a lot of standing water on the site, as seen by the photos above and below, on entrance and exit to the site the roads were checked for mud and debris leaving the permitted area; I was didn't observe any mud/debris on the main roads leaving the site.
