Compliance Assessment Report - A P Waters Building Contractors Limited

Officer Jonathan LEE in attendance of AP Waters Limited, Pontypool to complete a routine compliance inspection of the standard rules permit EPR-AB3898HB. Officer LEE met with company director Adrian Waters and SHEQ manager Craig Lilley.

The visit was made to undertake a routine inspection of the site, and to obtain an update on the construction of a building on site as mentioned in previous visits to the site.

Compliance

Site Activities

Permit condition 2.3.1 states that 'activities shall be operated using the techniques and in the manner described in Table 2.3. below': -

Table 2.3 Operating techniques

1. Unless stored or treated outside as specified waste³:
 - a) all bulking, transfer or treatment of non-hazardous waste shall be carried out inside a building;
 - b) all non-hazardous waste shall be stored in a building or within a secure container.
 - c) all non-hazardous waste shall be stored and treated on an impermeable surface with sealed drainage system.
2. Specified waste shall be stored and treated on hard standing or on an impermeable surface with sealed drainage system.
3. Asbestos waste shall be double bagged and stored within clearly identified, segregated, secure, lockable containers on an impermeable surface with sealed drainage system.

It was noted during the inspection that the operator has sought the construction of a building for the storage of wastes as required by point 1a) of Table 2.3. Skips of various sizes containing separated fractions of wastes were being stored within the building, as shown in the photograph below. The construction of this building confirms compliance with permit condition 2.3.1.

No issues with yard or drainage system apparent at time of inspection.

Site Management

Permit condition 1.1.4 states that ‘the operator shall comply with the requirements of an approved competence scheme’.

Actions have previously been scored for the operator to comply with this permit condition.

NRW received confirmation after the site inspection that company SHEQ manager Craig Lilley has passed the relevant WAMITAB qualification and is now the allocated Technically Competent Manager (TCM) for the site. As such, permit condition 1.1.4 has been complied with.
