Compliance Assessment Report – Smith's Waste Management (EPR-FB3432AY)

Environment Officers David WARWICK-BROWN & Alex BOWDER attended Smiths Waste Management on 01/08/2019, following a reported incident of significant increases in the number of seagulls in the area. The reporter of the incident indicated that the Waste Transfer Station was responsible for the issue and believed they were accepting non-permitted food wastes onto the site. Officers arrived on site at 10:15 and left at 10:30. The weather was sunny for the duration the inspection.

The purpose of the visit was to determine whether the WTS was accepting non-permitted wastes and to substantiate whether there were any seagulls on site. Seagulls apparently arrive in large numbers every day at 1pm following a delivery from ASDA. It was confirmed that none of the imported waste materials from ASDA contained any food wastes, but the seagulls appeared to be attracted to the odour produced from this waste material. There did not appear to be any food wastes on site, or any other non-permitted wastes. The Site Supervisor explained that Smith's have tried several pest control methods; however, they have not yet found an appropriate method yet due to the location of the site directly below the A4323.

There were no seagulls on site at the time of the visit and this incident was therefore not substantiated at the time of this visit. However, as there is likely a seagull issue, which has been acknowledged by the operator and other NRW staff, an investigation by site with an aim to improve the situation and decrease pests will be required.
