The site was inspected on 16 October 2019 by Sally Wakeford and Liane Bacon-Weekes. The inspection was a general inspection for new site officer to become familiar with the site. This CAR form relates to the MRF activities on site.

We were accompanied on site by Bruce Creamer.

Sampling

The sampling area required for the sampling of incoming and outgoing wastes for the MF Regulations was clean and tidy. Sampling had been undertaken that morning.

The handwritten sampling paperwork was still within the sampling area and 2 notes were checked, one input from Carmarthenshire white bags, and one output sample for paper. The samples results for the incoming and outgoing wastes are relatively consistent with the reported data in the last quarter. The paper output did calculate to be 97% whereas the reported is typically 99.5%. Therefore, on next inspection I will look to complete an audit of the sampling data sheets for specific streams of incoming and outgoing wastes and check them against the waste returns to ensure the sampling data is being reported as it is measured.

Waste Returns

Waste returns were checked and some errors in the reporting were noted. The reported figures for the input sampling for the majority of the input dated for each of the waste types (paper/plastic/metal) did not add up to the total target wastes.

Please ensure these errors are looked into, these will be checked again on next audit.

Baled wastes

The bales of sorted outgoing wastes from the Blue MRF were stored in the outside storage yard. The bales appeared consistent with the percentages reported in the waste returns.
