Environment officers Laoni Tye and Alex Bowder visited site on the 9th October 2019 and met with Chris Smith and Carl Jones. The visit was announced as site had been notified the previous day. The purpose of the visit was to assess compliance with the regulation 36 notice which had been issued with an end date of 30th September 2019. The notice was not deemed to have been complied with which is an offence and a breach was recorded. **No other areas of the site or permit were assessed.**

The notice was served due to breach of Condition 2.3.1, table 2.3 which states that all waste shall be stored inside a building or within a secure container and; all waste shall be stored and treated on an impermeable surface with sealed drainage system.

Because

Historical waste fines are being stored on unmade ground/hardstanding and require removal from site.

Condition 2.2.1 which states that waste shall only be accepted if: a) it is of a type and quantity listed in table 2.2.

Because

Unpermitted waste fines were accepted onto site and are currently being stored on a concrete pad outside of the building.

We received an email on behalf of the operator on the 27th September 2019 confirming that the notice was not going to be complied with. This was confirmed during our inspection as waste fines were still being stored on hardstanding and on the concrete pad.

It is an offence for a person to fail to comply with the requirements of an enforcement notice or of a prohibition notice, suspension notice, landfill closure notice or mining waste facility closure notice.

You have been breached a category 3 breach for non-compliance with the permit conditions referenced above, under C4 – Management – storage, handling, labelling and segregation. All waste not stored in line with the permit conditions should be removed from site and taken to an authorised facility.

We will now be considering our enforcement response, action is being considered.
