A routine site inspection was undertaken on Friday 18th October 2019.

The inspection was undertaken at a time following an extended period of heavy rain. The following observations were made:

Site Drainage

Following a period of very heavy rain, there was some pooling of water on site. This did not appear to prohibit on-site operations. It was noted that you intend to empty the water run-off storage system soon. It was mentioned on site that this liquid is taken to Mekatek Limited. Could you please provide a copy of the consignment note, when available, for our records.

Site Security & Waste Storage

An inspection of the site boundary was undertaken although not all areas of the boundary were accessible due to skip storage. The site appears to be well secure. It was noted that the site is served by a number of CCTV systems.

While inspecting the site boundary it did appear that small amounts of wood waste were almost toppling off skips, outside of the site boundary. It was agreed that this waste would be removed. You must ensure that all waste materials are kept securely on site.

End-of-life Vehicle Storage

At the time of the inspection an end-of-life vehicle had been incorrectly stored on an area of hardstanding. This was removed to a suitable area while officers were still on site.

In the future, please ensure that all un-depolluted end-of-life vehicles are stored on areas of the permitted site that benefit from an impermeable surface with sealed drainage system.

No non-compliances were recorded during the inspection.
