A routine site inspection was undertaken on Friday 18th October 2019.

The following observations were made:

Waste Storage & Vehicle De-pollution

In a previous inspection the inspecting officer recorded a non-compliance as all liquids from vehicle de-pollution process were stored together. This is in conflict of the Hazardous Waste Regulations. During the inspection on 18/10/2019 waste fluids/liquids appeared to be stored separately. Containers for each material were clearly labelled.

Vehicle de-pollution equipment was viewed and there was no record of faults/breakdowns at the time of the inspection.

The end-of-life vehicle de-pollution unit appeared to be well maintained. There was no evidence of spillages/leaks and no pollutants appeared to be leaving the building.

No non-compliances were recorded during the inspection.
