The Water Use Efficiency report was received on 8th November 2019.

The report is accepted.

Water use continues to fall, both overall and per unit produced. The proportion discharged to sewer is fairly constant at 64% of the total used on site.

TRW are using the BREF recommendations to minimise water use by optimising dwell times and withdrawal rates, controlling water flows and by jig design.

The proposed larger capacity jigs will also help to reduce drag out and enable more efficient water use per unit produced.

"BS ISO46001:2019 Water efficiency management systems - Requirements with guidance for use" was published earlier this year and TRW may find it helpful to refer to this document when considering further ways of conserving water.
