This CAR form is in response to an e-mail submitted to NRW by John Edwards on 16th June 2016 and subsequently a desk based audit of the EMS.

Within the e-mail and attached responses to recently issued CAR forms Atlantic have confirmed that the fines currently being stored within the transfer station are not those resultant from the processing of stockpile 1. Photographic evidence was also submitted to back this up.

However, within the justification Atlantic have confirmed that the MRF fines have been on site since before Christmas and so have been stored for a period in excess of 6 months.

### **C4-General Management-Storage, handling, labelling and segregation. Category 3 breach against section 1.1.1 of the permit held.**

This breach has been scored for the period of time that the MRF fines have been stored on site. The management system held for the site within IMS14-03 states that:

"Combustible fines will only be stored on site for a maximum time period of 1 month."

The fines that are on site are comprised of high levels of combustible wastes as can be seen in the images attached taken of the waste during an inspection carried out on 26th April 2016. These wastes have therefore been stored on site by far in excess of the timescales allocated during the management system and now in excess of timescales provided by the FRS and NRW for the safe storage of combustible wastes.

**ACTION:** Please ensure that these fines are removed from site and are taken to a facility that are permitted to accept them before 1st July 2016. In addition to this, please ensure that any future fines that are produced on site are removed within the 1 month timescale provided within the IMS. The excessive storage of waste on site is clearly an issues across many waste streams, please improve waste management practices to avoid future accumulations of waste.

With regard the comments on the 19th May 2016 CAR form, you are correct the 2103 figure is a typographical error and should have read 2013.
