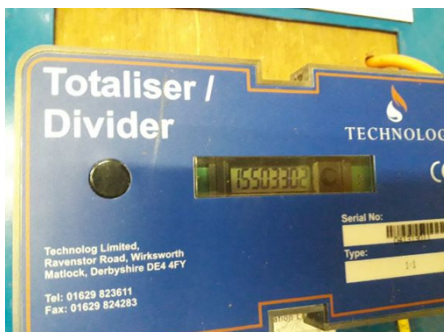

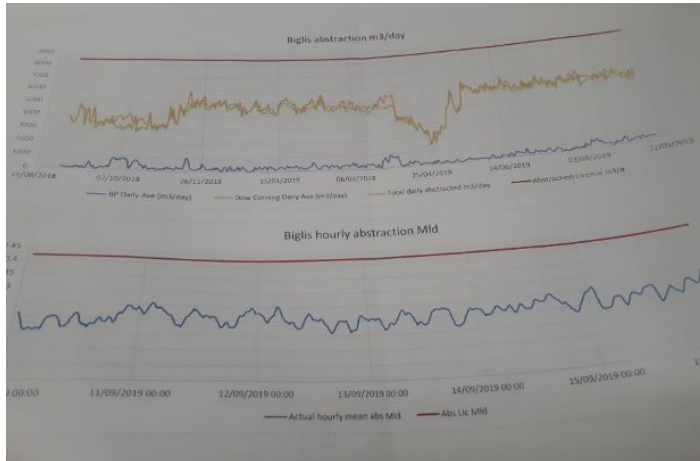
Observations/Comments

Environment Officers Kirsty Lewis and Hannah Jenkins visited Biglis Site on 17/09/2019 to assess Water Abstraction Licence Reference Number: 21/58/11/0002/V002. Met with Dwr Cymru Operators K. Betts, J. Reynish and A. Evans.

The two points of abstraction were correctly situated at NGR's 2.1 and 2.2. Based on records provided by K Betts (photograph of graph below) and current meter readings. Abstraction quantities did not go over permitted amounts. In addition, meter readings from totalisers are compliant below threshold.

Whilst, the actual meter readings are not taken from the photographs, there is discrepancy between the Technolog/Totaliser/Divider versus the Totalizer. With Dow having the most considerable discrepancy. There is an action towards the end of this report to address this.





Actions

1. Submit recent inspection notes of both boreholes as unable to inspect due to access issues.
2. Clarify why for each line (Dow and BP) there are two totalisers in place with different readings, these should be the same readings for consistency purposes. Although I appreciate these are not the meters used to submit annual returns.
3. Confirm when meters were last calibrated and date for recalibration
4. Submit records of water levels in boreholes OB2, OB3 and OB4
