Liz Park arrived on site and met with Barry Wills (Team Leader Powys (Waste water)) to undertake a Final Site Inspection for the surrender of the waste operation permit.

The permit enabled two distinct activities. The storage of wastes listed in Appendix B, and the acceptance for biological treatment and physio-chemical treatment of wastes listed in Appendix A.

There were no wastes stored in the bays.





Inside of the enclosed bay. These items belong to the staff.

The wastes that the sewage treatment works are permitted to be accepted for treatment were accepted at the location as shown in the photograph below. The pipe is still in place for the acceptance of septic tank and cesspit waste. There is a sign clearly saying that the pipe is only for the Inlet Discharge Point for tankered waste only.

Liz looked at the delivery book and the last wastes recorded in the book were accepted on 13 March 2017



The permitted area has been cleared of all wastes and is in a clean/ safe state. As the site remains a working sewage treatment works the infrastructure remains in place. There is no ongoing pollution risk from the permitted activities.
