Officer Hayley Barrett and Natalie Wrangham visited the site on 11/09/18 to check compliance with water abstraction permit **21/57/25/0046** regarding water abstraction from the Nant-y-Fforest stream.

On the day of the visit, we were informed the pipe leading from the pump was broken and had been so since 2015.

Records of the meter reading were recorded in the work diary each month, and each reading was the same since 2015.

We were shown a pond at the North-west of the site which supplied water for the works instead of the stream.
