CONDITIONS OF CONSENT TO DISCHARGE

Treated Abandoned Minewater Effluent ("the Discharge")

FROM: Corrwg Minewater Treatment System

1. (a) The Discharge shall not contain any poisonous, noxious or polluting matter or solid waste matter.

(b) Provided that the Discharge hereby consented is made in accordance with the following conditions of this consent, such discharge shall not be taken to be in breach of condition (a) above by reason of containing substances or having properties identified in and controlled by these conditions.

NATURE

2. The Discharge shall consist solely of Treated Abandoned Minewater from Corrwg Minewater Treatment Scheme.

LOCATION

3. The Discharge shall be made in the manner and at the place specified as:
 - (a) discharging via a velocity reduction Chamber;
 - (b) discharging to Afon Corrwg via 300mm Culvert;
 - (c) at National Grid Reference SS 8854 9969;
 - (d) shown marked 'Consent Point' on Plan BP0310201 attached as Annex 2.

SAMPLE POINT

4. The outlet to the watercourse shall be constructed, maintained and appropriately labelled so that a representative sample of the Discharge may be obtained at National Grid SS 8854 9969 as shown marked 'Consent Point' on Plan BP0310201.

VOLUME

5. The volume of the Discharge shall not exceed 4,675 cubic metres per day.
6. A flow measurement structure shall be provided and maintained to enable the daily flow rate of the Discharge to be measured or determined as required.

COMPOSITION

7. The Discharge shall not have a pH value less than 6.0 nor greater than 9.0 pH Units.
8. The effluent treatment facility shall be maintained in an efficient operational manner at all times.
9. As far as is reasonably practicable, the site shall be operated so as to prevent:
 - (a) any matter being present in the Discharge, other than matter specifically covered by numerical conditions in this consent, to such an extent as to cause the receiving waters, or any waters of which the receiving waters are a tributary, to be poisonous or injurious to fish in those waters, or to the spawning grounds, spawn or food of fish in those waters, or otherwise cause damage to the ecology of those waters; and
 - (b) the Discharge from having any other adverse environmental impact.

MAINTENANCE

10. The treatment system shall be operated and maintained in accordance with good operational practice such that:

For the Settlement Lagoons:

- (a) all settlement lagoons shall be desludged at sufficient frequency and in such a manner to prevent excessive carryover of suspended solids.

for the Reedbed:

- (b) ensure effective and even distribution of the minewater feed;
- (c) the minewater flow does not by-pass or short circuit within the Reedbed;
- (c) the discharge is collected and discharged at a single point;
- (d) the reedbed shall be maintained to prevent excessive weed growth;
- (e) the influent and effluent pipes shall be maintained in an efficient operational condition so as to minimise the probability of blockages or other failures;

RECORDING AND REPORTING

- 11. The Consent Holder shall establish and operate a documented maintenance programme and record all non-routine actions undertaken that may have adversely affected effluent quality. Copies of the programme shall be made available for inspection by the Agency's Officers on request.
- 12. The Consent Holder shall supply the Agency with an annual written report confirming operation of the maintenance programme.
- 13. The Consent Holder shall, as soon as reasonably practicable, report all non-routine actions that may have adversely affected effluent quality.






The determinands listed above will be sampled monthly. Samples should only be taken under 'normal' operating conditions i.e. not during maintenance or emergency. The results of the monitoring shall be submitted to the Agency after a period of 12 months and 24 months.

A UKAS accredited laboratory shall be used in the analysis of the above determinands.

Further to your application the Agency has decided that consent should be given subject to conditions. I enclose the Agency's formal consent to discharge other matter effluent from Corrwg Minewater Treatment System (West Bank) at Glyn Corrwg.

Under the present Scheme of Charges for Discharges to Controlled Waters an annual charge will be made for all consents to discharge, except where the discharge is of sewage effluent of five cubic metres or less per day. The charge is based on information derived from the conditions attached to the consent to discharge, as outlined in the enclosed leaflet.

If you consider that the conditions imposed by the consent are unreasonable you have a right of appeal to the National Assembly for Wales at Cathays Park, Cardiff CF10 3NQ.

Notice of an appeal must be given in writing within three months of this notification and must be accompanied by a statement of the grounds of appeal.

If granted, a consent under Schedule 10 of the Act, covers water quality considerations only. It does not alter the need to obtain any other consents or approvals which might be required in connection with your proposal under other legislation. For example it does not give any right or permission to discharge where land is not owned by the applicant.


