This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

This variation is to combine the Waste Transfer station and Material Recycling facility into a waste transfer station with treatment, allow treatment via mechanical means, include EWC code 17 01 07 - mixtures of concrete, bricks, tiles and ceramics other than those mentioned in 17 01 06 to the wastes permitted to be accepted on site and update the permit to modern conditions.
