The accompanying information is that sent in with the deployment form and any additional information received during the assessment.

- cause offence to human sense,
- result in damage to material property or
- impair or interfere with amenities or other legitimate uses of the environment or use processes which could endanger human health or harm the environment.

- breach any requirements relating to [Environmental Impact Assessment \(EIA\) Regulations \(2002\)](#)

If you fail to comply with these requirements you may be committing an offence and enforcement action may be taken against you.
