A check of waste returns has highlighted that waste returns for permit number NB3634RX have not been submitted to Natural Resources Wales for quarters 3 & 4 (July – September and October to December 2018).

Permit condition 4.2.2 states:

Within one month of the end of each quarter, the Operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter.

Should the site not accept or remove waste during any quarter then NIL returns should be submitted.

All returns should be submitted as follows:

Q1 1st January – 31st March submitted by 30th April

Q2 1st April – 30th June submitted by 31st July

Q3 1st July – 30th September submitted by 31st October

Q4 1st October – 31st December submitted by 31st January

Advice and guidance has previously been given regarding late submission of waste returns on Compliance Assessment form number CAR_0033579 & CAR_0033717

The above observation has resulted in a **Category 4 breach** which has been recorded against G4 Monitoring and Records.

ACTION: Missing waste returns to be submitted by 15th March 2019.
