Site visited on 26th March 19, accompanied by Philip Caldwell, Denbighshire County Council.

Concern raised over integrity of foul system and potential impact on the surface of the adjacent field. Dye placed into initial chamber of the foul system and agreed plan in place to visually monitor for emergence of dye.

On the 27th March 19, the dye emerged into a ponded area on the surface, showing a link between the foul system and the surface. This is a breach of condition 3.1.1. :

*There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.*

Site agreed to suspend brewery discharge to the foul system and removed waste liquid from site by a contractor until the required improved infrastructure installed. Site to undertake investigations into specific source of the failure and undertake improvement measures.
