This was a visit in response to an incident reported to NRW; timeline of incident report via ASH to NRW below:

15:00 Steve Rymill contacted Steven White directly to inform that a fire had broken out on site, digger that feeds the inert trommel had caught fire in the main sorting building. North Wales Fire and Rescue Service (NWFRS) are on site

15:30 Steve Rymill updated that the fire had been extinguished and NWFRS are still on site until digger has been removed and building made safe

15:55 Steve White and Callum Brannan arrived on site and met with Steve Rymill and Keith Morris. Fire had started in the digger that feeds the inert trommel, site operatives used on-site fire extinguishers to initially tackle the fire but were unable to extinguish it, NWFRS subsequently called and attended site. Fire was put out quickly and contained to the digger; some minor damage to the building from the smoke and heat but the building was still structurally sound.

Steve White liaised with NWFRS Incident Commander who took him to the burnt out digger (see photo below). Two pumps attended and approximately 5000 litres of water was used to extinguish the fire - Dwr Cymru were notified by NRW that this runoff would enter the combined sewer system that services this area.

NWFRS waited on site until the digger had been moved from the building in case there were any hotspots that could flare up.

Site Fire Prevention and Mitigation Plan was utilised during the incident and NWFRS were able to ascertain the location of hydrants, access to the site for the pumps and information on sensitive receptors was readily available for the crews. After a brief discussion with Director Zoe Hassell Officers left site.

Site was operational as usual the next morning.
