Waste Returns

Waste returns have been submitted on time by the operator as required under **condition 7.2.2**.

Waste Acceptance

Following the inspection a review of the most recently submitted waste returns from the site was undertaken and an issue has been identified. **Under condition 1.2.1** of the environmental permit, the site is only able to accept wastes categorised in **Table 1.2A** and detailed in **Appendix A** of the permit. The submitted waste returns show that paints under the hazardous waste code **20 01 27*** have been accepted on site.

****Amendment:** Clarification has been provided to NRW by the operator confirming that the hazardous paints are accepted onto site under an S2 waste exemption NRW-WME034263 (valid to 8/10/21). The previous breach has been removed.

Environmental Management System

Currently the EMS that NRW holds on record is dated March 2017. Please can you confirm that this is the current working plan for the site. At present the EMS states that 20 01 27* is a permitted waste type however as outlined above, this particular waste code is missing from **Appendix A** of the permit and subsequent variations.

Storage of materials.

Wastes on site were stored in individual labelled bays and containers. The containers were in good condition with no signs of damage or spillages in line with **condition 2.1.1** of the permit.

Infrastructure site drainage

During the inspection it was noted that cracks had developed in the drainage system on the lower level. **Condition 2.1.2** of the environmental permit, the site drainage and impermeable pavements are required to be inspected and maintained. This has been scored as a **category 3 breach** of permit.

Action - Please ensure that maintenance is carried out on site infrastructure once inspection identify issues.
