Thank you for forwarding the relevant monitoring and performance indicators for quarter 2 period from 01/07/2019 to 30/09/2019 and also for the emissions to air.

E1) – Emissions to air.

Monitoring results for A1 undertaken on 23/07/2019. No breaches of permit noted.

E3) - Emissions surface water.

Permit condition 3.1.2 stipulates that the limits given in Schedule 3 shall not be exceeded. The following breaches of limits have been noted

Temperature results showed 29.48 degree against a permit limit of 25 degrees.

A part A and B notification form was submitted to NRW for this exceedance. It is encouraging to see that actions are being taken in regards to this matter, in particular lagging the pipework to protect against high temperature from direct sunlight, and to relocate the temperature probe to more suitable location.

Due to the fact that the site has breached emission limit value at a point source to surface water a **CCS breach of 3** has been noted against permit condition 3.1.2
