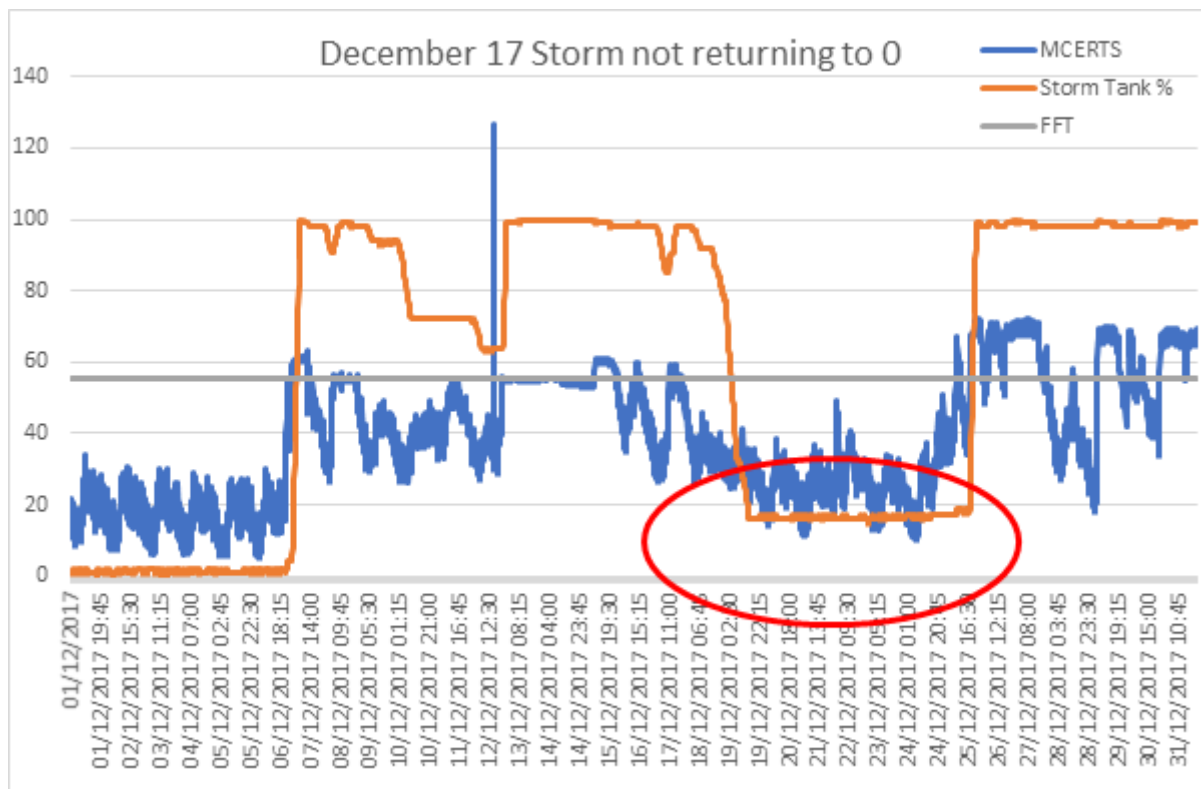
This was a pre arranged audit carried out by Julia Lloyd and Tim Arlett, NRW Environment Officers. Accompanied by DCWW employees.

It was recorded that there is an ongoing issue with the biological filter beds clogging and media not working as it should. The filter beds are scheduled to have a full media refurbishment as part of the amp 7. Further information has been received and NRW have been notified that this refurbishment has commenced. 4 SAF units were observed, we were notified that these are in place to augment against the failing filterbeds.

There was one non-compliance recorded during the audit.

Flow data has been received, following inspection we have noted that in storm conditions sometimes the works is treating well over FFT at 60/70 l/s and at other times it is just under FFT.

ACTION - Please see graph below and note the area marked in red, the storm data is showing that the storm tank has not emptied completely as required.
