Bioaerosol monitoring was carried out on the 24th July 2019 by Cardiff Metropolitan University on behalf of Bryn Group Limited, as part of the compliance requirements of the environmental permit EPR-WP3995FY held by Bryn Compost Limited. However, this permit was surrendered by the operator in September 2019.

As such this Compliance Assessment Report has been issued to assess compliance with the environmental permit EPR-WB3993HE held by Bryn Recycling Limited.

The bioaerosol monitoring report submitted by Cardiff Metropolitan University states that monitoring was carried out in accordance with the Association for Organics Recycling (AfOR) standardised protocol. The results indicated that bioaerosol threshold limits as detailed within the permit were below the specified limits; 300 CFU/m³ for gram-negative bacteria, 1000 CFU/m³ for mesophilic bacteria and 500 CFU/m³ for *Aspergillus fumigatus* at all locations monitored.

The results of this monitoring confirm compliance with Permit Condition 3.5.1, referring to Schedule 3, Table S3.1 of the permit.
