On 7th November 2019 a routine inspection was carried out to assess compliance with permit conditions.

Please be aware that this CAR form contains a **WARNING** for a breach of permit condition 21 (c).

The condition states "the sewage works shall be operated and maintained in accordance with good operational practice such that: (c) tanks shall be desludged at sufficient frequency and in such a manner to prevent excessive carry-over of suspended solids".

At the time of my inspection the humus tanks were silty and effluent containing suspended solids was over-topping the baffle into the channel. The channel itself was silty and contained significant number of leaves. Whilst it is appreciated the weather has been wet and windy, the build-up has occurred over significant time and is unacceptable.

Also the copus bags were full and require cleaning or replacing.

Please ensure maintenance is carried out by the 28th November to ensure there is no potential risk of suspended solids being carried over and discharged to the watercourse.

Due to the recent weather conditions the discharge pipe was below the level of the watercourse. No discolouration, fungus, rags or odour were detected.

The permit has UWWTR conditions. As the Population Equivalent is 1386 these conditions should not be part of the permit.

Could you please apply for a Variation to remove these conditions as soon as possible.
