Barry Docks Site Visit – South Wales Exports (EPR/BB3293NH) – 16/12/2019

Environment Officer Craig Coleman visited the South Wales Exports facility at ABP, Barry Docks, Vale of Glamorgan on 16/12/2019 to undertake a routine inspection. The site manager Nathan Curtis accompanied me around site during the visit and discussed the waste storage procedures that were undertaken to help maintain compliance with the Environmental Permit.

(C1) Staff Competency and Training:

Site manager Nathan Curtis is still in the process of completing the WAMITAB certification, Gareth Jones (a company director) is remains the technically competent person for the facility in the interim period.

(C3) Materials Acceptance:

The waste metal streams on site were well separated between ferrous and non-ferrous metals. There were three ELV's on site, but they had been depolluted and were stored on site in preparation for export.

(C4) Storage, Handling, Ladling & Segregation:

The waste quarantine section was mostly empty. There was a small amount of Waste Electrical and Electronic Equipment held in the area awaiting shipment on to an authorised treatment facility.

(D1) Security:

The site is secured by a 7ft perimeter fence which is locked when the site is non-operational. Associated British Ports (the landlord) also operate an onsite security team that patrols the Dock on a 24h basis.
