On 23 August 2019 a site inspection was undertaken by Sally Wakeford and Eleanor Davies. We were accompanied on site by Stuart Hanford.

Before conducting the site inspection, we discussed the following:

- It was confirmed that all legacy filter cake stockpile waste was removed. Current outlets are Tir John & Trecatty Landfills, for use in cells, bunds and capping. Discussions are underway with Pwllfawtkin landfill for their extension.
- the waste found beneath the filter cake stockpile and you informed us you were currently processing 850 to 1000t per week after a period of being down in production.
- The removal of silt from the silt traps once a month and brought back up to the washplant.

ACTION: Please provide the section of the EMS for Site engineering for pollution prevention/design and construction and drainage design/maintenance.

- Stock rotation plan in place and working. The current model is that of 2 years ago. Your current stockpile of filter cake is a maximum of 2 months of production.

Site Inspection:

It was evident that the large stockpile of filter cake had been removed from site, and a large proportion of the waste underfoot had also been removed. As can be seen from the photographs below, the level underfoot appeared to be at approximately ground level in the area we were able to access.

The outlet from the lagoon appeared to be running free and clear of any suspended solids.

There was a stockpile of recent filter cake, approximately 2 months' worth.

Recent breakdowns of machinery and a slow processing rate meant that not as much waste had been processed as would be ideal, however this is now up and running at full capacity.

The stockpiles of final aggregate appeared consistent in size.

The next inspection will focus on the WRAP protocol, and how the site implements testing and will request sampling results to show conformity with the protocol to ensure the materials on site can be deemed no longer waste.
