Extensive concreting has been carried out to the east of the ELV depollution bay which extends southwards to the old depollution bay. New drainage has also been installed around the site. Richard Safadi has stated the next part of the site that will be improved is the area around the weighbridge.

A bailer has been purchased and is expected to arrive soon.

Stewart Owen, planner, has been investigating the planning permission requirement for the installation of bunding around the site. The bund is to assist with pollution prevention and noise attenuation. The bund is made up from scrapings from the surface of site which is surplus material following extensive concreting works. The scrapings may be contaminated with oil from historic activities and also contained metals plastic and glass. The bunding has been seeded and grass is growing.

To prevent delay providing this Compliance Assessment Report, we will write to you regarding this matter at a future date.

A request has been made to supply 12 months of data showing all waste delivered to the site. This has been received, thank you.
