Those attending were MY, Director, Dragon Recycling Solutions (DRS); WH, Director, DRS; TM, Compliance Manager, DRS; BB, Business Development Manager, DRS; Ian James, Senior Officer, Industry Regulation, Natural Resources Wales (NRW); Rebecca Green (RVG), Senior Officer, Industry Regulation, NRW.

### Smart Meters

SMETZ 2 meters are not yet approved. There is a communication problem between them and the hubs. A lot of meters presently being installed are manufactured outside the EU and there seems to be some confusion as to who is actually responsible for their disposal. Non-EU manufacturers are exempt from the Producer Responsibility Regulations. The meter distributors are based in the UK. All smart meters contain lithium batteries and so the disposal problems associated with them will only increase. There are, or could be, about 52 million in circulation.

### Mercury Recovery

The plant will stay at the Rhymney site, it will not be relocated to the new site at Tafarnaubach. Dragon may be getting the meter recycling contract back as they can do all the necessary work (dismantling, mercury recovery, metal and plastic recovery and metal and plastic disposal or recycling) on one site.

The plastic from meter housings is not classified as hazardous but the classification for the plastic from television housings is unclear. RVG recommended that Dragon carry out a WM3 assessment on this plastic as they seemed fairly confident that they could obtain a reasonably accurate composition from the plastic manufacturer. Ian James offered to assist with the assessment.

### Tafarnaubach Site

This is progressing much more slowly than Dragon would like, owing mainly to the unwieldy planning regulations. Work cannot progress until the planning permission is granted.

It is unlikely that the proposed operations on this site will be Schedule 1 activities.
