## Schedule

### 1. **Percolation test results for the proposed new site of the drainage mound**

We require the percolation test results for the proposed new site of the drainage mound. The new site must be outside of the flood risk zone as demonstrated on the map you provided via email. The percolation test should be carried out at least three times with at least two trial holes.

### 2. **Updated site plan for new site**

Please provide us with an updated site plan for the new drainage mound location. This needs to include the pipework connecting the package treatment plant to the wetland system and then to the drainage mound. The site plan also needs to indicate the location of the groundwater monitoring point that is downgradient from the drainage mound.

### 3. **Monitoring point NGR and design details**

We require a National Grid Reference for the downgradient groundwater monitoring point. The construction details for this monitoring point also need to be provided.
