Weather conditions: cold, overcast, light wind.

General discussion and handover.

Partial capping of Cell 4 planned for 2020.

Site walkover. Strong landfill gas odour detected near W71 (Type 1 well). W71 measured with Gazomat at base of well. Methane reading 6000ppm. Investigation carried out by site following this. Site measured 2300ppm in this location. Pressure measured as 103mbar (vacuum) at manifold and 4mbar (vacuum) at well head. Site suggested that line is damaged between W71 and manifold.

2.5% methane measured at W80 (Type 2 well) measured with Gazomat at base of well.

Permit condition 3.1.1 states that there shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.2, S3.3 and S3.4.

The methane emissions detected at the base of W71 and W80 are considered to be a Category 3 breach of condition 3.1.1.

Actions:

1. Operator to investigate failure of gas collection line at W71, and repair as necessary, reporting back to NRW by 31.01.2019.
2. Operator to complete a Gazomat survey of all Type 2 wells, reporting back to NRW by 31.01.2019.

NRW intends to complete a full landfill gas audit at the site in 2020.
